Item 1 - Chairman's Opening Remarks:

Item 2 - Introduction from the new RNA General Secretary, Captain Bill Oliphant RN:

After an extensive handover from Captain Paul Quinn, Bill has been in post as RNA General Secretary since Dec 18. His last role in the RN was Captain of the Base in Portsmouth and he was privileged to have been involved in the preparations and indeed for the arrival of HMS Queen Elizabeth. Mindful that Association numbers are diminishing and therefore a common issue for us all, whilst certainly not a take over bid, the RNA is happy to embrace Veterans where smaller organisations are no longer viable and who which to continue to enjoy the camaraderie that association brings.

Item 3 - Captain NCR Cooke-Priest RN, Commanding Officer HMS Queen Elizabeth:

CONA were honoured and delighted to hear from the Commanding Officer; his presentation, delivered with obvious enthusiasm was most informative and sparked a range of questions. It was fascinating to realise the required shift in routines and processes once familiar to us all (including Defence Watches, Duty Watches and Rounds routes) and enforced the enormity of the vessel – 850 ships company for over 3000 compartments! The Chair offered our sincere thanks to Captain NCR Cooke-Priest RN for his inspiring presentation.

Item 4 - Chairman of the CONA Working Group – RNA and CONA:

Bill Oliphant acknowledged the importance of CONA and was delighted to meet representatives from a range of Associations at the meeting today. He is conscious that the RNA is perhaps better resourced than many of the CONA Associations and offered any support where possible.

Item 5 - Naval Service Command Needs Analysis – Feedback:

NavSec has tasked RNRMC with the delivery of a number of Workshops to address prevalent issues faced by serving personnel; Bill and Sarah attended to represent the RNA. Whilst some current issues are new, the need for camaraderie and friendship remains and more so within the Veteran community to address social isolation and loneliness. Belonging to an organisation and interacting with like-minded people is good for general well-being: reunions, meetings and social events led by CONA committees are very much appreciated not only to keep naval traditions alive but to offer a sense of belonging. Ian Millen from Veterans Outreach Support ([VOS](#)) added that as well as access to a range of health professional and delivery partners, the Monthly VOS Drop-Ins at both Portsmouth and the IoW provide Veterans with the opportunity to socialise; to enjoy having some company for a while and to meet new friends. Any other business:

1. The importance of Making a Will and Lasting Power of Attorney - This recent
guidance issued by RNA as featured in Feb 19 Circular:

*Making a will - is vital if you want to be sure your wishes are met after you die. That is the
only way you can be sure that your money/property/possessions and investments (known as
your estate) will go to the people and causes that you care about. If you and your partner are
not married or in a civil partnership, then your partner will have no right to inherit on your
death. You can find very comprehensive help and advice on the Age UK site or by calling
0800 055 6112 0800 –1900 every day of the year. They will send out the appropriate leaflets
and also advise you on the documents relating to your will that you need to keep together.

freewills@brishlegion.org.uk or call 0203 053 7087 0203 207 2253 and they will inform you of solicitors in your area who are ready to help. • Lasting Power of Attorney (LPA) - An LPA is a way of giving someone you trust the legal authority to make decisions on your behalf. There are two types of LPA for financial decisions LPA for health and care decisions. Finance If the time comes when you cannot make a particular decision and you haven't created a valid LPA then the Court of Protection may need to become involved. Health and Care Without an LPA and you no longer have mental capacity the Court of Protection would make the decisions on where you live, your health care, your contacts in fact all aspects of your living. Both LPA's can be a safeguard if you do not wish to make decisions on your way forward. It does not necessarily mean you have lost mental capacity but are perhaps just not well enough to consider anything relating to finance or care. Someone needs the authority to pay the bills or deal with any household problems liaise with your GP. You can download all the necessary forms to complete both LPA's on line and then print them off to be signed by going to this Link www.gov.uk/power-of-attorney/make-lasting-power The LPA's need to be registered with the Office of Public Guardian for which there is a charge. This can vary according to any benefits you may be claiming. This information applies to England and Wales for Northern Ireland and Scotland go to appropriate site.
